**DOG LICENSE REGISTRATION**

**PLEASE NOTE THAT THE CITY MAINTAINS A REGISTRY OF LICENSED ANIMALS AND WILL NO LONGER BE ISSUING METAL TAGS.** All dogs **MUST** be licensed with the City by January 31<sup>st</sup>. Fine for non-licensed dog is \$75.00-\$100.00. Maximum number of dogs and/or cats allowed by City Ordinance is three (3). No registration or fee required for domestic cats.
