Alderman Wright – Inquiry about home business licenses. A traffic sign is down on Roan Ridge. Alderman Hoover – Signage needed on Prairie View warning of children walking along the roadside. Alderman Cory – Inquiry as to whether the BBQ food truck will be collecting taxes (yes). Park Director Rollins – Upside Down is the newest tenant at Imeson House on Sunday mornings. Resident music teacher, Micah Woulfe's spring concert had overflowing attendance!

FINANCIAL REPORTS

Candice Wortman, City Treasurer provided the report on the City's financials for February, with no concerns noted. Mayor Smedley stated commercial sewer bills, continue to be escrowed for payment pending MO. American Water

Alderman Snyder moved to approve Paybills Resolution #03-14-24, Alderman Wright seconded, and all voted aye.

- Garage Sale Resolution During city-wide garage sales, the parking restrictions (within the city) will be relaxed. Alderman Hoover motioned to approve. Alderman Cory, seconded, and all voted aye.
- Application for a 2024 Stormwater Grant. Hoover motioned to approve. Alderman Cory seconded the motion, all voted aye. To prepare an Authorization Letter to Platte County regarding 2024 Grant.
- Ordinance update/code revisions Occupational License, Building Permit fees, and Public Safety issues.
- Replatting of business area Division of business area into 4 separate plates.

OLD BUSINESS

Right of way access – Mayor Smedley feels the utilities are doing a good job of returning property to its original state.
