

The Board of Aldermen of the City of Platte Woods, Missouri met November 14, 2018 at City Hall, 6750 NW Tower Drive, Platte Woods, Missouri.

**OPENING-** The meeting was called to order by Mayor Smedley at 7:02pm. Smedley asked the Council to review their copies of the October 10, 2018 meeting minutes and today's agenda with modification to Public Comments adding new business application. Mayor asked for a motion to approve the minutes from October 10, 2018, and agenda.

Alderman Lawson motioned to approve, Alderman Cory seconded the motion, all voted aye.

### **PUBLIC PARTICIPATION-**

-Jerry Sirna, CPA, presented on behalf of his client, to open a new business in Platte Woods, ATC Weapons, LLC. His client currently own a firearms customization business in Kansas City. His client wishes to open an additional location in Platte Woods at the 6500 NW Tower Drive building. The business consults with local Police Departments in suppling firearms. Mr. Sirna shared that there would be a limited number of firearms on the premises. His client deals with online orders and customization of firearms.

- -Alderman Lawson asked if the public were able to purchase customization items from the new business. Mr. Sirna stated that the public does have the option of ordering online for coming into the business to purchase firearms. Mr. Sirna added that all firearms are kept in a safe under lock and key and not on display.
- -Alderman White confirmed that Mr. Sirna is the accountant on record for the owner and the firearm business. Mr. Sirna answered that he currently works for his client, the owner, and the current businesses in operation. Alderman White asked if there had been any concerns from other cities about the firearm business. Mr. Sirna shared that he would like to have the business up and running within 30 days.
- -A Platte Woods resident asked about the type of firearms that are sold. Mr. Sirna said that all types of firearms are available to customers online.

- -Alderman Hoover asked about the number of employees. Mr. Sirna said there will be only one employee working on location at the business.
- -Mayor asked if the business would carry and sell ammunition. Mr. Sirna said that ammunition is sold on a very limit basis. Mayor asked about signage for the business. Mr. Sirna stated that ATF requires 2 identification markers for the firearms business. Mayor inquired about any additional ATF regulation and Mr. Sirna said there is no other requirements. Mr. Sirna stated that Fedex handles shipping for the business and conducts each shipment with great detail. Mr. Sirna added that no additional surveillance is needed because there is already video monitoring on the building. The hours of operation are estimated to be 10am-8pm daily.

- -Alderman Lawson asked who residents are to contact about a dead deer within the city of Platte Woods. Mayor stated that either the resident or if the deer is located on a street, the City is responsible. MODOT is responsible if the location of the deer is on state highway.
- -Alderman White inquired about the Lake Waukomis police agreement. Mayor stated the agreement is going well and there has been positive response from Platte Woods and Lake Waukomis residents.
- -Alderman Hoover asked about the virtual photos for the City website and lighting at Imeson Park. Mayor stated that no additional lighting or virtual photos would be addressed at this time. Mayor added that the completion of the kitchen at Imeson Park should be November 30<sup>th</sup>.
- -Alderman Cory had no comments at this time.
- -Mayor shared that Imeson Park is being utilized and rented by the residents on a regular basis. The Eagle Scout are currently working on the library and bird house at the park.

### **POLICE REPORT-**

- -Officer Noon gave the report on police activity for October 2018.
- -A Platte Woods resident expressed her concern with Police response time in Platte Woods. Deputy Chief Noon shared that all police agencies face the same concerns and Platte Woods is continuing to improve response time.
- -Officer Noon stated that the Police Department as currently updated the phone system and the public will need to contact the Police at the non-emergency number, 816-741-7973.
- -Deputy Chief Noon announced that Office Skidmore has been assigned to the administrative position for Lake Waukomis. Officer Skidmore will work as a liaison for Platte Woods and Lake Waukomis.

- -Mayor shared that Kansas City Fire Department has offered an agreement with municipalities to help with replacing batteries for elderly and disabled individuals in smoke and CO2 monitors. Mayor would like to utilize this program for Platte Woods residents.

### **OLD BUSINESS-**

-Mayor passed out the signage request for Skandalous Tattoo. Mayor asked for approval for the signage at Skandalous Tattoo. Alderman Cory motioned to approve the signage, Alderman White seconded the motion. All voted aye, motion passed.

### **NEW BUSINESS-**

- -Mayor asked for a motion to approve new business in Platte Woods, ATC Weapons, LLC. Alderman Hoover requested the motion be tabled so that discussion could be held with Chief Kerns.
- -Mayor motioned to go into closed session-Pursuant to RSMo. 610.021 (3)
